## **Planned Business:**

#### Interclub 7's COP

Document - Conditions of Play (COP) with supporting examples was tabled. The COP as outlined below for the 2023-2024 were agreed.

#### **Definitions**

**Round**: A round is defined as a head-to-head Club versus Club in singles, pairs, and fours. Example: Carrington versus Masterton in singles, pairs, and fours.

**Session:** As interclub is using a split round format each day is divided into 3 sessions. Example: Carrington V Masterton singles, pairs and fours may be split between different sessions.

**Format:** All clubs in the Interclub 7s competition will play each other twice. Within a round, a player may only play in 1 discipline. Each club can determine who they wish to select to play in each discipline, position, and round. I.e., a club can bring in new players, change disciplines, and/or positions between rounds.

Fours to play 15 completed ends. No time limit.

Pairs to play 18 completed ends. No time limit. Singles to play first to 25 shots. No time limit.

- In all games 7 points for a win, 4 points for a draw. 0 for a loss.
  A bonus of 1 point is awarded to a team or singles player gaining a game differential of 11 shots or more in any discipline. A bonus of 1 point is awarded to a team or singles player losing a game by 1 or 2 shots in any discipline.
- All games must be played right out unless a player or players cannot continue due to illness or other exceptional circumstances. In the case of teams defaulting, all points scored will be revoked. Each team played or to be played will receive seven (7) points.
- Entry fee. A mat fee of \$1.00 per player per game collected by
- the Club and paid to the Executive Officer each year by the End of October.
- Clubs must participate in all rounds, irrespective of positional standing. Any club in
- breach of this rule may be ineligible for the following season's competition.
- This event will be run as a single Division.
- The winning Club will be deemed Champion Club and will progress further to the National finals.

Note: A player can play up to 3 games in an interclub 7s team and remain eligible for a Hannam Knowles team.

For clarity, the Centre Booklet will change the wording next year to read 'Each club may enter one side of Seven (7) players to play Singles, Pairs and Fours in each round'.

#### Tablets for Tournament Controllers

It was decided they were not required for use with the new Bowls Hub system. Tournament controllers could use printed scoring sheets and then text/call them through to the EO.
